# Dickens Heath Parents, Teachers & Friends Association AGM 2017

Minutes of the Annual General Meeting of the Parents, Teachers & Friends Association held at Dickens Heath Community Primary School, Three Acres Lane, Dickens Heath, Solihull, West Midlands, B90 1NA on Wednesday 18<sup>th</sup> October 2017.

#### 1) Notice and attendees

In accordance with the PTFA constitution, notice of the meeting had been given 21 clear days in advance (on 26<sup>th</sup> September 2017) and a quorum was in attendance. A register of attendees/voters may be obtained from the PTFA secretary.

#### 2) Annual Accounts

The chairperson proposed that the accounts for the Association for the financial period ended 31<sup>st</sup> July 2017 be received and adopted. This template is accepted by the Charity Commission for England & Wales for the purpose of charity registration. There were 36 votes in favour and 0 votes against. The chairperson declared the resolution passed and the constitution adopted.

### 4) Annual Report

The chairperson proposed that the report of the committee of the Association's activities since the previous AGM be received and adopted. There were 36 votes in favour and 0 votes against. The chairperson declared the resolution passed and the report duly received.
